The Faculty of Forestry at the University of Toronto and the University of Toronto DO NOT provide any insurance coverage for participants. Students are responsible for maintaining OHIP or other provincial or international health insurance coverage at all times during the field camp. No insurance coverage is provided by the MFC Program for loss or damage to any personal property (e.g., clothing, cameras, computers, etc.) during the field camp.

I, the UNDERSIGNED, hereby acknowledge that certain RISKS OF PERSONAL INJURY OR PROPERTY LOSS are inherent to my participation in this program. Risks may be minor or serious and may result from my own actions or the actions or inactions of others, or a combination of both. I agree for myself, and my family, heirs and executors that THE GOVERNING COUNCIL OF THE UNIVERSITY OF TORONTO and its officers, employees, agents and assigns shall not be liable for any injury to my person or loss or damage to my personal property arising from or in any way resulting from my participation in FOR418/FOR1585 Urban Forest Conservation Field Camp UNLESS such injury, loss or damage is caused by the SOLE NEGLIGENCE OF THE UNIVERSITY OR ITS OFFICERS, EMPLOYEES, AGENTS OR ASSIGNS while acting within the scope of their duties.
